WHEREAS, the State of Texas, Office of the Governor, Criminal Justice Division (CJD) has made funds available to aid agencies with the purchase of rifle resistant body armor during FY 2022-2023; and

WHEREAS, the increased program and funding source would benefit the City of Dallas in its endeavor to increase officer safety; and

WHEREAS, the City of Dallas agrees that in the event of loss or misuse of the CJD funds, the City of Dallas assures that the funds will be returned to the CJD in full; and

WHEREAS, the City of Dallas designates the City Manager or an Assistant City Manager as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter or terminate the grant on behalf of the applicant agency; and

WHEREAS, it is in the best interest of the City of Dallas to accept such funding.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager or designee is hereby authorized to apply for and accept the Rifle Resistant Body Armor Grant in the amount of \$762,049.50 (Grant No. 4238402) from the Office of the Governor, Criminal Justice Division, to provide for the purchase of rifle resistant body armor for the Dallas Police Department for the period September 1, 2022 through August 31, 2023; and execute the agreement and all terms, conditions, and documents required by the agreement, approved as to form by the City Attorney.

SECTION 2. That the City Manager is hereby authorized to establish appropriations in an amount not to exceed \$762,049.50 in the CJD-Rifle-Resistant Body Armor Grant Program 2023 Fund, Fund S391, Department DPD, Unit 323C, Object 2790.

SECTION 3. That the Chief Financial Officer is hereby authorized to receive and deposit grant funds in an amount not to exceed \$762,049.50 into the CJD-Rifle-Resistant Body Armor Grant Program 2023 Fund, Fund S391, Department DPD, Unit 323C, Revenue Code 6516.

SECTION 4. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$762,049.50 from the CJD-Rifle-Resistant Body Armor Grant Program 2023 Fund, Fund S391, Department DPD, Unit 323C, Object 2790.

SECTION 5. That in the event of loss or misuse of funds, the City of Dallas will return all grant funds to the Office of the Governor, Criminal Justice Division, in full.

SECTION 6. That the City Manager is hereby authorized to reimburse the Office of the Governor, Criminal Justice Division in the event of loss, or misuse of funds, in full. The City Manager shall notify the appropriate City Council Committee of any return of grants funds not later than 30 days after the reimbursement.

SECTION 7. That the City Manager shall keep the appropriate City Council Committee informed of all Criminal Justice Division final monitoring reports not later than 30 days after receipt of the report.

SECTION 8. That this contract is designated as Contract No. DPD-2023-00020637.

SECTION 9. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
