In March '23, Downtown Dallas' Crime Score was **9x** higher than Downtown Ft. Worth and experienced:

- **23x** more motor vehicle thefts
- **17x** more thefts
- **8x** more assaults

**Notes:**

- (1) For ease of comparison, the Metroplex Civic & Business Association uses the crime score weightings used by The Dallas Express news publication: <https://dallasexpress.com/crime-methodology/>
- (2) Given a lack of granularity in the Fort Worth crime data, crimes of a similar nature in Dallas have been summed into the above crime categories for a more accurate comparison
- (3) Crime types not included in both City's datasets were excluded so as to provide the most comparative analysis possible (Disorderly Conduct, Extortion / Blackmail, Traffic Violation - Hazardous, and Trespass of Real Property)
