NARRATIVE:

ARRESTING OFFICERS (AO'S) T. FURY #11710 AND C. HENSON #11505 CONDUCTED THE TRAFFIC STOP ON A WHITE 2006 CHEVY IMPALA (TEXAS TEMP TAG #91026A6). THE DRIVER WAS WITNESS RODRIGUEZ, DAVID AND THE PASSENGER WAS ARRESTED PERSON BECKAM, WILLIAM. DURING THE INVESTIGATION AO'S FOUND THAT WITNESS RODRIGUEZ, DAVID HAD A NO EXTRADITION, FELONY WARRANT OUT OF COLORADO AND ARRESTED PERSON BECKAM, WILLIAM HAD A LIMITED EXTRADITION ONLY, WARRANT OUT OF CALIFORNIA, AO'S SPOKE TO SGT. CARDENAS #9005 TO ADVISE ON THE NO EXTRADITION WARRANTS. AO'S T. FURY #11710 AND C. HENSON #11505 ASKED WITNESS RODRIGUEZ, DAVID TO STEP OUT OF THE VEHICLE TO SPEAK WITH AO'S ABOUT HIS NO EXTRADITION WARRANT THE WITNESS RODRIGUEZ, DAVID HAD FROM COLORADO. AO T. FURY #11710 STATED TO WITNESS RODRIGUEZ, DAVID THAT HE WAS GOING TO MAKE SURE THERE WERE NO WEAPONS INSIDE OF THE VEHICLE AND CHECKED THE HOT ZONES OF THE DRIVER SEAT OF THE VEHICLE. WHILE OFFICER T. FURY #11710 WAS CONDUCTING A TERRY FRISK OF THE WITNESS RODRIGUEZ, DAVID VEHICLE 2006 WHITE CHEVY IMPALA (TEXAS TEMP TAG #91026A6) FOR WEAPONS, OFFICER C. HENSON #11505 ASKED ARRESTED PERSON BECKAM, WILLIAM TO STEP OUT OF THE VEHICLE AND PATTED THE ARRESTED PERSON BECKAM, WILLIAM DOWN. OFFICER C. HENSON #11505 FELT A BULGE CONSISTENT WITH A GLASS METH PIPE LOCATED ON THE RIGHT SIDE OF THE ARRESTED PERSON BECKAM, WILLIAM WAIST BAND. C. HENSON #11505 ASKED T. FURY #11710 TO GRAB THE PIPE (DRUG PARAPHERNALIA) FROM OUT OF THE ARRESTED PERSON BECKAM, WILLIAM WHICH WAS CONCEALED INSIDE OF HIS UNDERWEAR. WHILE LOOKING IN THE PASSENGER SIDE OF THE VEHICLE OFFICER T. FURY #11710 OBSERVED A HANDGUN (TARUS 9MM TAP71299) UNDER THE FRONT PASSENGER SEAT TUCKED IN BETWEEN THE CORNER OF THE SEAT AND FLOOR BOARD AND CENTER CONSOLE WHERE THE AP WAS SITTING. THE HANDGUN WAS VISIBLY POSITIONED FROM OUTSIDE OF THE VEHICLE WITH THE BARREL POINTING TOWARD THE REAR OF THE VEHICLE WHILE THE GRIP OF THE WEAPON WAS TILTED UPWARD AND EXPOSED FROM THE SEAT AND FLOORBOARD OF THE VEHICLE. AO T. FURY #11710 CLEARD THE HANDGUN IN A SAFE DIRECTION AND AO'S THEN IMMEDIATLEY DETAINED BOTH THE WITNESS RODRIGUEZ, DAVID AND THE ARRESTED

PERSON BECKAM, WILLIAM WITH HANDCUFFS FOR OFFICER SAFETY. A GUN CHECK WAS CONDUCTED BY AO HENSON THROUGH DISPATCH AND REVEALED CLEAR.

AS AO HENSON ESCORTED ARRESTED PERSON BECKAM TO THIER POLICE VEHICLE ONE LARGE BAGGIE CONTAINING A WHITE CRYSTAL LIKE SUBSTANCE FELL FROM ARRESTED PERSON BECKAM . AS THE BAGGIE OF WHITE CRYSTAL LIKE SUBSTANCE HIT THE GROUND AO HENSON OBSERVED THAT IT MAY BE METH AND MOVED ARRESTED PERSON BECKAM AWAY. AO C. HENSON SEIZED THE LARGE BAGGIE CONTAINING THE CRYSTAL LIKE SUBSTANCE FOR FEILD TESTING. AO HENSON ALSO CONDUCTED A SEARCH OF ARRESTED PERSON BECKAM'S LUNGE AREA OF THE SUSPECT VEHICLE AND FOUND ONE BLACK CLOTH BAG IN THE FLOORBOARD. THE BLACK CLOTH BAG CONTAINED SEVERAL SMALLER BAGGIES CONTAINING MORE CRYSTAL LIKE SUBSTANCE BELIEVED TO BE METH, WHITE POWDER BELIEVED TO BE POWDERED COCAINE, WHITE ROCKS BELIEVED TO BE CRACK COCAINE, GREEN LEAFY SUBSTANCE BELIEVED TO BE MARIJUANA, NUMEROUS SMALL EMPTY BAGGIES, A SMALL SCALE, AND ONE GLASS BOWL. AO HENSON ALSO OBSERVED A CASH APP CARD WITH ARRESTED PERSON BECKAM'S NAME INSIDE THE BLACK CLOTH BAG. ALL THE CONTENTS OF THE BLACK CLOTH BAG THAT WERE BELIEVED TO BE NARCOTICS WERE SEIZED BY AO HENSON FOR FEILD TESTING. THE REST OF THE CONTENTS OF THE BLACK CLOTH BAG THAT WERE CONSISTENT WITH DRUG PARAPHERNALIA INCLUDING THE GLASS PIPE FOUND ON ARRESTED PERSON BECKAM WERE SEIZED AND TAKEN TO THE BAYLOR STREET PROPERTY ROOM ON TAG NUMBER 261264B. AO HENSON ALSO FOUND ONE OVER THE COUNTER PAIN CAPLET STILL IN BUBBLE PACKAGING THAT WAS DEPOSITED ON THE DRUG TAG 122054D. PERSONAL PROPERTY FOUND INSIDE THE BLACK CLOTH BAG WAS DEPOSITED ON PRISONER PROPERTY TAG NUMBER 111127P. THE CHANGE FOUND INSIDE THE BLACK CLOTH BAG WAS DEPOSITED ON MONEY TAG NUMBER 023586M.

SGT.D. WESTURLAND #7972 FEILD TESTED ALL NARCOTICS AT THE SCENE. AO HENSON #11505 WITNESSED THE TEST OF THE NARCOTICS. NARCOTICS TESTED POSITIVE FOR METH, COCAINE, AND MARIJUANA. ALL THE DRUGS FOUND WERE TRANSPORTED BY AO C. HENSON 11505 TO THE BAYLOR STREET PROPERTY ROOM. AO HENSON WEIGHED ALL DRUGS AND ALL DRUG WEIGHTS ARE APPROXIMATE:

THE POWDERED COCAINE, CRACK COCAINE, AND ALL METH WERE DEPOSITED ON DRUG TAG NUMBER 122054D TOTAL WEIGHT OF THE DRUG TAG BAG AND ALL CONTENTS WAS 173.9 GRAMS.

-FOR THE POWDERED COCAINE IN THE GREEN BAGGIE THE DRUG WEIGHT WITH PACKAGING WAS 0.4 GRAMS, THE PACKAGING WEIGHT WAS 0.2 GRAMS, AND THE DRUG WEIGHT WITHOUT THE PACKAGING WAS 0.2 GRAMS.

-FOR THE CRACK COCAINE IN THE WHITE BAGGIE THE DRUG WEIGHT WITH PACKAGING WAS 0.5 GRAMS, THE PACKAGING WEIGHT WAS 0.4 GRAMS, AND THE DRUG WEIGHT WITHOUT THE PACKAGING WAS 0.1 GRAMS.
TOTAL WEIGHT OF ALL COCAINE SEIZED WAS 0.3 GRAMS.

-FOR ALL METH IN PACKAGING SEIZED THE DRUG WEIGHT WITH PACKAGING WAS 121.4 GRAMS, THE PACKAGING WEIGHT WAS 3.7 GRAMS, AND THE DRUG WEIGHT WITHOUT THE PACKAGING WAS 117.7 GRAMS.

THE MARIJUANA SEIZED WAS DEPOSITED ON DRUG TAG NUMBER 122081D AND THE TOTAL WEIGHT OF THE DRUG TAG BAG AND ALL CONTENTS WAS 42.7 GRAMS

-FOR THE THREE MARIJUANA CIGARETTES IN BAGGIE THE DRUG WEIGHT WITHOUT THE PACKAGING WAS 0.7 GRAMS, THE PACKAGING WEIGHT WAS 0.2 GRAMS, AND THE DRUG WEIGHT WITHOUT THE PACKAGING WAS 0.5 GRAMS.

-FOR THE MARIJUANA IN PACKAGING THE DRUG WEIGHT WITHOUT THE PACKAGING WAS 10.5 GRAMS, THE PACKAGING WEIGHT WAS 3.6 GRAMS, AND THE DRUG WEIGHT WITHOUT THE PACKAGING WAS 6.9 GRAMS.

WITNESS RODRIGUEZ, DAVID WAS TOLD NOT TO DRIVE AWAY FROM LOCATION DUE TO NO DL AND WITNESS RODRIGUEZ, DAVID WALKED BACK TO A STORE TO WAIT ON A RIDE FROM A FRIEND. THE WITNESS VEHICLE WAS PARKED LEAGALLY IN THE PARKING LOT OF PLANET FITNESS.

SGT S. CARDENAS 9005 WAS NOTIFIED FOR THE RELEASE AND UN-HANDCUFFING OF WITNESS RODRIGUEZ, DAVID AT THE SCENE.

ARRESTED PERSON BECKAM IS BEING CHARGED WITH UNLAWFUL POSSESSION OF FIREARM BY FELON DUE TO HIS FELONY CONVICTIONS IN THE PAST. ARRESTED PERSON BECKAM HAS BEEN CONVICTED OF AGG ASSAULT WITH A DEADLY WEAPON ON 3/11/2015 BY THE 118TH DISTRICT COURT IN BIG SPRING TEXAS. ARRESTED PERSON BECKAM SERVED 7 YEARS IN THE TEXAS DEPARTMENT OF CRIMINAL JUSTICE AT HUNTSVILLE. ARRESTED PERSON BECKAM ALREADY HAS PREVIOUS UPF CHARGES ON HIS RECORD.
