# Proposed Bond Technical Criteria



## Background:

- Each Department develops their own Technical Criteria based on departmental needs/concerns/expertise.
- Departments score the Needs Inventory with a maximum of an 80-point technical score.
- After the technical score has been assigned, the points for the 'Priority Areas-Overlays' will be assigned to each project by the Department of Data Analytics and Business Intelligence.
  - 10 points for priority overlays
  - 10 points for Equity

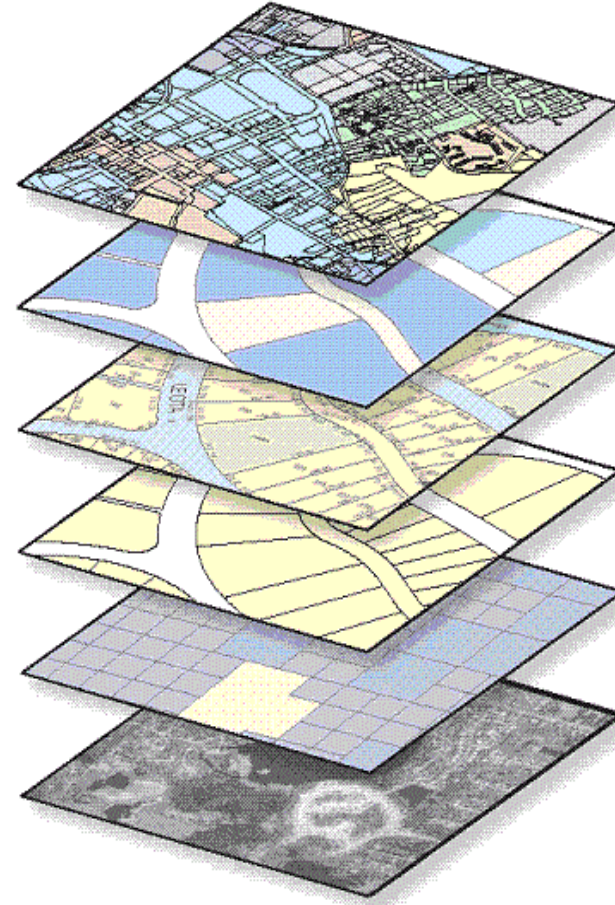
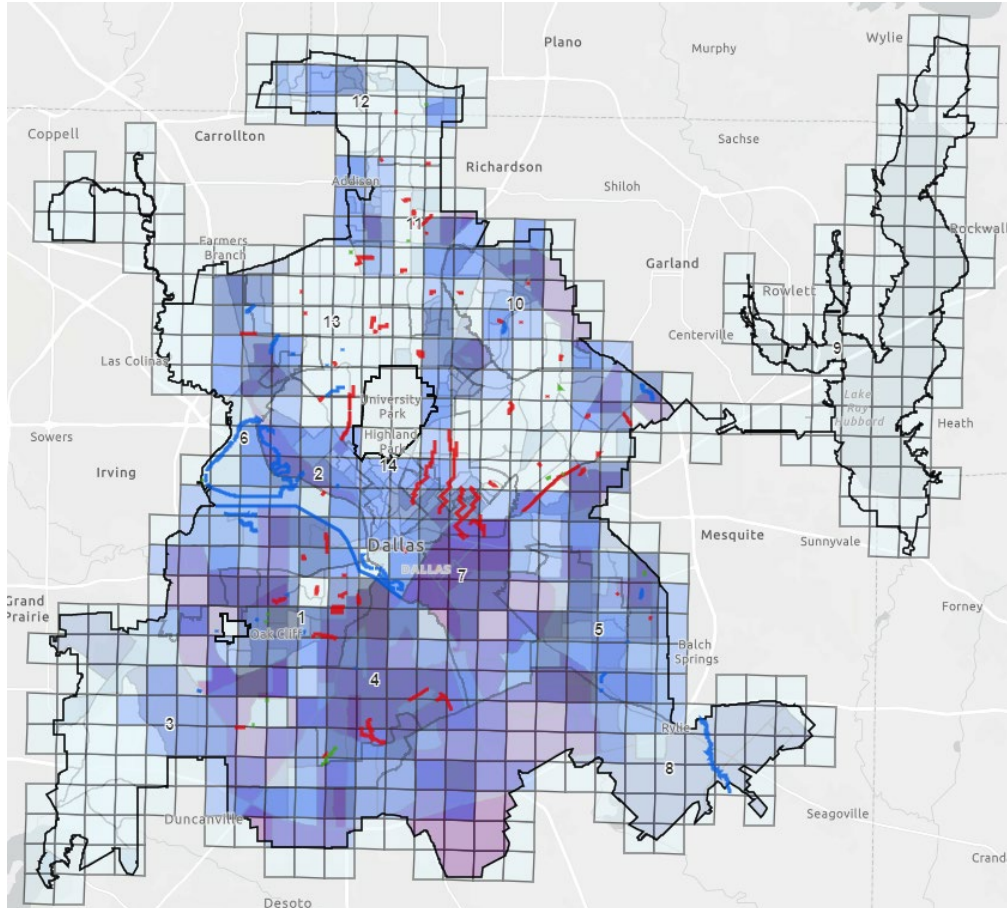




# Priority Areas – Overlay Process



- The priority areas were determined by overlaying multiple data layers (see image below) and have been added to the 'GIS Technical Scoring Tool' for reference.

High Crime Areas

TOD (DART Sites)

Market Value Analysis

311 Service Requests

Identifying calls for Flooding, Speeding, Traffic Calming, Potholes, Street Resurfacing, and Illegal Dumping

Intersection/ Project Overlay

## **Equity Impact Assessment (EIA)**

### **Score Up to 10 Points**

Working with Office of Equity & Inclusion

- Entire city is given a ranking; 1-5
- EIA score multiplies ranking by 2 for total points used.

  - All non-infrastructure department led propositions
  - Bond Funds become available for projects as they are developed and approved by council, up to the proposition limit.
    - February 6, 2023 - Economic Development briefed the Eco-Dev Committee by memo.
    - April 24, 2023 - Housing briefed the Housing and Homeless Solutions Committee.
    - May 22, 2023 - Homeless Solutions – Briefed the Housing and Homeless Solutions Committee.

# Proposed Bond Technical Criteria



## Council Input

**Street projects should use actual traffic volumes rather than street classification.**

- *Public Works investigated available traffic data from NCTCOG. The data appears to not be current or useful to assign traffic volumes to roads. Therefore, in absence of traffic data, the functional street classification is used where Arterials, Collectors, and Local streets are assigned 15 points, 10 points, and 5 points, respectively.*







## Council Input

**Have PBW scoring for Improved and Unimproved street reconstruction have points associated with projects that address the Vision Zero Policy?**

- *One of Transportation's project category is vision zero/safety. This category is intended to address the causes of fatal and severe injury crashes at high injury locations. The project list from this category will be overlaid with Public Work's list and additional 2 points will be allocated to Public Work's projects.*

# Proposed Bond Technical Criteria

## Council Input

Use the importance of a building affected on a scale of 1-5, not just the number of buildings. Giving preference for effect on critical infrastructure buildings, important city and public safety facilities, hospitals, major employers, high dollar installations etc.

*DWU will look at flood management and storm drainage projects in the needs inventory and determine their impact on critical buildings using a spatial analysis (GIS). Critical buildings will be broken into the following categories in ascending priority and projects could be assigned up to an additional 5 points.*

- 1 – Large Commercial
- 2 – Schools
- 3 – City Facilities
- 4 – Public Safety Facilities
- 5 – Hospitals
