BEFORE ME, the undersigned authority, on this day personally appeared the undersigned affiant, who after being duly sworn on oath deposes and says; My name is **DETECTIVE M. E.**Anderson #3119, FORT WORTH POLICE DEPARTMENT, and I have good reason to believe and do believe that on or about the 19<sup>th</sup> day of June, 2023, in Tarrant County, Texas, Decarlos Donte Jordan, a black male, date of birth 08/17/1987, hereafter known as the suspect, did then and there commit the offense of:

THEN AND THERE KNOWING THAT AN INVESTIGATION WAS IN PROGRESS, NAMELY a homicide investigation, DID (ALTER OR DESTROY OR CONCEAL) A THING, TO-WIT: a handgun, WITH INTENT TO IMPAIR ITS VERITY OR AVAILABILITY AS EVIDENCE IN SAID INVESTIGATION, TO-WIT discarded a firearm used in a shooting so that officers could not locate it.

My belief is based upon the following facts and information:

Your Affiant, Det. M. E. Anderson ID 3119 is a certified Police Officer employed by the City of Fort Worth, Fort Worth Police Department, located at 1000 Calvert St, Fort Worth TX.

On Wednesday, the 19<sup>th</sup> day of June 2023 at approximately 10:23 P.M., Fort Worth Officers were dispatched to shooting call at Cook Children's Hospital located at 801 7<sup>th</sup> Ave, Fort Worth, Tarrant County, Texas.

Officer Hoffman arrived on scene and learned that Trey-Shawn Eunes 12-06-2010 (12 years of age) was transported by private vehicle to Cook Children's Hospital for a gunshot wound. Trey-Shawn Eunes later died at 10:48 P.M.

Officer Hoffman requested the on-call Homicide Detective to call him.

I responded to the hospital and interviewed both Jarvis Eunes (father to Trey-Shawn Euens) as well as Rashad White and learned the following:

- Jarvis Eunes and Rashad White were at an office building on Brentwood Stair Road with several friends (Hamma, Carlos and Tank)
- Jarvis was outside the office building grilling food.
- Trey-Shawn was inside one of the suites playing video games and that the suite belonged to "Hamma"
- Rashad White stated that he and his three-year old son,
   arrived and son went inside the room where Trey-Shawn was playing the video game.
- They were outside when a gunshot was heard and Trey-Shawn ran outside holding his side.
- Jarvis saw that Trey-Shawn had been shot and he loaded him into Rashad White's vehicle and they went to the hospital.
- Jarvis and Rashad were able to provide information that the location where the shooting occurred was at 5504 Brentwood Stair Road Suite 107.

I later spoke with Trey-Shawn Eunes mother, Lakesha Bay. She stated that she knew "Hamma" and that his real name is

Sergeant Loughman went to 5504 Brentwood Stair and met with who has a suite inside the building near suite 107. provided Sergeant Loughman access to his digital video recorder since one of his cameras is pointed down the hallway where suite 107 is. Below is what I observed from the video:

- At approximately 2214 hours (DVR Time), a black male, who was later identified as is seen running out of suite 107 followed by Trey-Shawn Eunes as well as a younger male believed to be
- Afterwards, a black male wearing blue shorts and a white shirt, who is later identified as DeCarlos Jordan, appears to be walking into the room where the shooting happened and then walked back out of the suite holding a handgun in his left hand.
- Mr. Jordan is seen mopping the hallway outside suite 107 as well as carrying multiple unknown items out of suite 107.
- is also seen on video walking into the room where the shooting occurred and then back out carrying a bag containing unknown items out of the room.
- locks suite 107 and he and Mr. Jordan leave at the same time.

A search warrant was obtained the same night of the shooting and executed for 5504 Brentwood Stair Road Suite #107. During the search of the suite, a single fired 9mm cartridge casing marked "WMA 20" was found but a gun was not located.

Detective Abrams contacted the owner of the building complex, who provided additional video footage for the building. Upon reviewing this footage, I observed the following:

- Trey-Shawn Eunes is seen collapsing into the arms of his father, Jarvis Eunes at the exit door to the building.
- Mr. Eunes carries Trey-Shawn to a vehicle and they leave along with Rashad White and
- Mr. Jordan is seen mopping a large pool of blood in the parking lot where Trey-Shawn Eunes collapsed.
- Mr. Jordan enters the room where the shooting occurred and removes what appears to be a rifle and places it inside a vehicle outside.
- Mr. Jordan then takes the mop that he was using to clean up the floor and parking lot and places it inside a vehicle and then drives off.

After speaking with stated that his brother, was in the other room playing video games with Trey-Shawn and that was in the room as well. said that after the shooting happened he claims that he grabbed bags containing his clothing and left. stated that he never saw a gun and didn't know where the gun came from that shot Trey-Shawn.

After speaking with Decarlos Jordan BM 8-17-1987. He stated that he was in another room when he heard a "pop." Mr. Jordan ran into the room and picked up a black handgun after the three-year-old dropped it. Mr. Jordan stated that he put the gun in another room but doesn't know what happened to it afterwards. Mr. Jordan admitted to cleaning up blood off the floor with a mop and then left.
Based on the investigation at this time, it appears that the three-year-old, picked up a handgun from within the room and accidentally fired it, which struck Trey-Shawn Euens.
Through this investigation, it is clear that DeCarlos Jordan was aware that a shooting had occurred. De Carlos Jordan then cleaned up the crime scene with a mop, removed unknown items from the crime scene and concealed / removed the firearm that shot Trey-Shawn.
That based on the above facts and information being related to him, and as a result of his investigation, your affiant has reason to believe and does believe that <b>Decarlos Donte Jordan</b> , a black male, DOB: 08/17/1987, knowingly and intentionally did then and there commit the offense
of TAMPER/FABRICATE PHYSICAL EVIDENCE.
