Llano County, its Judge (Ron Cunningham), its 4 County Commissioners (Jerry Don Moss, Linda Raschke, Mike Sandoval and Peter Jones), its Library Director (Amber Milum) and 4 of the 13 members of the Library Advisory Board (Gay Baskin, Rhonda Schneider, Rochelle Wells and Bonnie Wallace) have been sued in Federal District Court in Austin on April 2022 for relocating pornographic and other harmful content OUT of the children's sections of the library.

We are extremely fortunate to have Jonathan F. Mitchell (former Solicitor General of Texas who clerked for Antonin Scalia and wrote the Texas Heartbeat Bill) defending us in this frivolous suit.

To date, we have spent close to \$200,000 on this lawsuit and we have not even gone to trial yet. A loss would ensure that the radicals would continue pursuing more radical means to indoctrinate our children. If Llano County loses, the entire country loses.
