Proposed Steps in our Process:

Week of December 18th:

• SHAC members will get a reviewer information form to get access to the curriculum materials that they determine they want to review.

January 1st

- Access to the curriculum for SHAC members to review with 24-7 access from January 1st to January 19th
 Utilize the user-friendly scoring sheet available with considerations to use in the review

<u>January 8th SHAC meeting</u>
• Presentations from curriculum representatives based on the number that the SHAC wants to hear from to inform scoring and for Q & A of representatives

January 19th

SHAC members scoring sheets submitted

January 22nd

SHAC meeting with results from scoring. Determine which curriculum the SHAC is leaning towards recommending to share in public meetings for comment.

Week of January 29th

Community presentation meetings and curriculum access, reviews, and public comment.

February 5th

• SHAC meeting to determine its initial curriculum recommendation to the board.

SHAC Co-Chair Criteria from Bylaws


Article 8, Section One:
