That **MELANIE LYNN SHARP**, hereinafter called Defendant, **on or about the 16th day of March, 2017** in the County of Dallas, State of Texas, did unlawfully, then and there intentionally, knowingly, recklessly, and with criminal negligence, engage in conduct that placed KAYLAN BORDEN, a child younger than 15 years of age, in imminent danger of death, bodily injury and physical and mental impairment, BY EXHIBITING AND USING ILLEGAL DRUGS AND DRUG PARAPHERNALIA IN THE PRESENCE OF SAID CHILD, and the defendant did not voluntarily deliver the child to a designated emergency infant care provider under Section 262.302 of the Family Code,



Affiant's belief is based upon facts and information in the narrative which is attached and incorporated herein, which Affiant received from :



Narrative.....

On 03/16/2017 Detectives from the Richardson Police Department executed a search warrant at 1804 Clover Trail, Richardson, Dallas County, Texas. Prior to executing the search warrant Detectives had determined that the residence was controlled by David Duane Sharp (W/M, 08-06-1946). Detectives made entry into the residence and identified the occupants as David Duane Sharp, Janice Sharp (W/F, 12-17-1950), Melanie Sharp (W/F, 02-13-1975), John Loviscek (W/M, 07-10-1987), Julia Romani (W/F, 08-20-1977), and a fourteen year old female child. Detectives found a glass marijuana pipe in a room to the west of the front door. The room was a common area room without doors or walls surrounding it.

In a bedroom later determined to be the fourteen year old child's bedroom Detectives found a marijuana bong and a small, round, white pill with the numerals "319" imprinted on the pill. The pill was later identified as Tramadol Hydrochloride using the pill identifier on the Internet website drugs.com. Tramadol Hydrochloride is a controlled substance available by prescription only. One of the cautions listed for the medication is overdose or death.

In the master bedroom Detectives located methamphetamine in a nightstand. The nightstand also contained checks drawn on David Duane Sharp's bank account.

Detectives lifted up the mattress for the bed in the master bedroom and found a poster sized photograph of a completely nude female body. The photograph had been altered with the image of the fourteen year old female child's face electronically added to the photograph over the face of the original model. Detectives also found a document titled "Stories by daddy's little slut muffin" in a trash can of the master bedroom. Detectives obtained a second search warrant specifically for evidence related to the possession of child pornography and resumed their search of the residence. Detectives seized multiple computers and electronic media storage items from the residence.

A search of a computer disc found in the master bedroom revealed two images of child pornography. The images are of teenage girls with their breasts exposed and in one of the images the vagina of the teenage girl is exposed in addition to the breasts.

Melanie Lynn Sharp is accused of Abandoning or Endangering Child, TPC 22.041, a State Jail Felony as a result of a marijuana bong and a controlled substance being found in the bedroom of a fourteen year old child placing the child at risk of death, bodily injury, or physical or mental impairment.
